

2025 Rotary Club of Tulsa Above and Beyond Service Awards Nomination Form

PURPOSE

The Rotary Club of Tulsa initiated the Above and Beyond Awards to recognize and honor professionals within Tulsa's police and fire departments, who through their exceptional performance of community service activities, have distinguished themselves above and beyond the call of duty.

OBJECTIVE

The Rotary Club of Tulsa's Above and Beyond Awards acknowledges one police officer and one firefighter who demonstrate outstanding acts of character, commitment, and compassion to both profession and community.

ELIGIBILITY

All sworn, full-time Tulsa Police officers and firefighters below the rank of chief are eligible. Eligibility includes assistant police chiefs and district fire chiefs. Nominations may be made for exceptional achievement in any police or fire prevention endeavor that exemplifies commitment to their duties "Above and Beyond" what would normally be expected. Outside community service will be an important criteria used in the selection process.

NOMINATION PROCESS

All nominations will be reviewed based on the detailed information submitted with the application with particular emphasis on any community service or other activities outside of normal work duties.

- Step 1: Prepare a Narrative In 500 words or less, please provide written detailed information regarding why you are nominating this individual for a Rotary Club of Tulsa Above and Beyond Award.
- Step 2: Gather Supporting Documentation Additional support documentation in encouraged, such as letters of support, news articles, report, etc. These may be attached to the nomination form.
- Step 3: Submission Submit to the Rotary Club of Tulsa no later than February 28, 2025.

ENDORSEMENT

Nominations my be made by an associate or superior, however, it must have a signed endorsement from the administrative head.

NOTIFICATION

Winners will be notified the first week of April.

AWARD WINNERS

Winners will receive a trophy recognizing their accomplishment. Additionally, their names will be engraved on a wall plaque for display within their respective departments. **Finally, a \$5,000 donation, in their names, will be awarded to the charity of their choice.**

AWARDS PRESENTATION

The winner and two personal guests, along with the recipient's chief, supervisor, direct report, and nominator will be invited to attend the Rotary Club of Tulsa's Above and Beyond Awards luncheon on Wednesday, May 7, 2025, at 11:30am at First Methodist Church, 1115 S. Boulder Ave., Tulsa, OK.

DEADLINE

Nomination forms and all documentation must be received no later than February 28, 2025.

ABOVE AND BEYOND AWARD CRITERIA

This award is presented to one police officer and one firefighter for outstanding service and deeds to their department, community, and profession. Selection criteria may include the following:

- 1. Exemplifies the qualities expected in their respective profession.
- 2. Displays a good attitude toward the public and the department which they serve.
- 3. Is a consummate professional with an exemplary work ethic
- 4. Represents their department in an honorable manner and serves their community with pride, honor, and service.
- 5. Serves and participates in community-based organizations or projects that positively reflect upon the police officer or firefighter, the department, and favorably impacts the Tulsa community.
- 6. It is recognized that it is difficult to distinguish between an officer and firefighter's everyday duties and their service to the community outside those duties. Therefore, even though community service is an important criterion to consider when determining who is to receive this award, going "above and beyond" those everyday duties will be afforded equal importance.
